ACKNOWLEDGMENT AND ASSUMPTION OF RISK
AND
WAIVE AND RELEASE FROM LIABILITY

I _____, know that skiing and snowboarding competitions and events are action sports carrying significant risk of serious personal injury, death or property damage. I also know that there are natural, mechanical and environmental conditions and risks which independently or in combination with my activities may cause property damage or severe or even fatal injuries to me or others. I agree that I alone am responsible for: (a) my safety while participating in competitive events and/or training for competitive events and (b) providing, utilizing and maintaining the equipment necessary for the safe enjoyment of my participation in such events and I specifically acknowledge that BOYNE RESORTS, the ski area, any agent representative, officer, director, employee, member or affiliate of any person or entity named above are not responsible for my safety. I specifically RELEASE AND DISCHARGE in advance, those parties from any liability whether known or unknown, even that liability which may arise out of negligence or carelessness on the part of persons or entities mentioned above. I agree to accept all responsibility for the risks, conditions and hazards, which may occur whether they be known or unknown.

Being fully aware of the risks, conditions and hazards of the proposed activity as a competitor, coach or official, I HEREBY AGREE TO WAIVE, RELEASE AND DISCHARGE any and all claims for damages for death, personal injury or property damage which I may have or which may hereafter accrue to me as a result of any participation in competitive events or training for competitive events, against any person or entity identified above whether such injury or damage was foreseeable or not, including any such claims regarding course design or maintenance or the design or condition of any equipment utilized by me in such competitive events without regard to whether such equipment is specified or recommended by such persons or entities identified above.

I further agree to forever HOLD HARMLESS and INDEMNIFY all persons and entities identified above, generally and specifically, from any and all liability for death, personal injury or property damage, resulting in any way from my participating in competitive events or training for competitive events

I agree that I will accept and abide by the rules and regulations of BOYNE RESORTS and any other rules or regulations imposed by the organizers of any particular competition. This Acknowledgment and Assumption of Risk and Waiver and Release from Liability shall be binding upon my heirs and assigns.
